**IMPORTANT INFORMATION ABOUT THE CORNISH TOWN DRINKING WATER SYSTEM has a Not Approved rating with the State of Utah Division of Drinking Water.**

Our water system is generally in non-compliance due to physical deficiencies and/or violations resulting in a Not Approved rating with the Utah Division of Drinking Water. The Utah Division of Drinking Water maintains ratings for all public water systems. An Approved rating shows that a public water system is generally in compliance with all rules and regulations to maintain safe drinking water. A Not Approved rating shows a water system is generally in non-compliance through physical facility deficiencies or violations.

Although this is not an emergency, as our customers, you have a right to know the rating of your public water system, and what we are doing to correct this situation. The following table shows the specific issues within our system:

**What should I do?**

**You do not need to use an alternative (e.g., bottled) water supply.** However, if you have specific health concerns, consult your doctor.

**What does this mean?**

This is not an immediate risk. If it had been, you would have been notified immediately.

**What happened? What is being done?**

We anticipate resolving the Pitcher Well problem next year spring and have obtained an engineer study. The Pitcher well is anticipated to be worked on next year.
